

## **IAG Your Voice/Our Voice Online Community Member Agreement/Terms and Conditions**

In these terms:

- “we” or “IAG” means IAG New Zealand Limited
- “Your Voice” means the online community created specifically for IAG customers
- “Our Voice” means the online community created specifically for IAG staff
- “you” means you, the person that we have invited to participate in our Your Voice/Our Voice community surveys and discussion groups, or visiting our Your Voice/Our Voice Web site

Please note Personal information collected on the site may be stored or processed in Singapore and you consent to any transfer of information outside New Zealand. They do not alter or affect any other policies or terms and conditions that apply when IAG provides you or your organisation with insurance products or services.

### **Notification of Changes**

We may change or revise the terms and conditions in this Agreement from time to time by updating this posting. Please visit the terms and conditions area each time you visit the Web site to keep up to date with the current terms regarding your use of the Web site. Your use of the Web site reaffirms your

continuing agreement to the then-current terms and conditions. Any future changes to these terms and conditions will be posted on the community Web site.

### **Your obligations**

Your invitation to participate in the Your Voice/Our Voice community is personal and non-transferable. You or anyone in your household or immediate family cannot work for a marketing, market research, media, advertising or public relations firm, in politics or for another insurance provider, supplier or broker. For the avoidance of doubt, employees of IAG are eligible to participate in the Your Voice/Our Voice community.

You may not disclose to others any of the information that we disclose to you or any ideas or information that are generated in the community. Your community member name and password are for your use only. You may not disclose your password to any other person.

### **Membership**

In order to qualify as a member of Your Voice/Our Voice you must:

- (a) be a current customer of IAG or employee of IAG;
- (b) be at least 15 years old;
- (c) register online at <https://www.iagyourvoice.co.nz> (providing your full name, address and email address) and complete an introductory survey, which we will use to determine your suitability for the Your Voice/Our Voice research community;
- (d) not be excluded under the 'your obligations' section above; and
- (e) be accepted by IAG as an Your Voice/Our Voice community member.

### **Code of Conduct**

You agree not to upload, post or transmit to or distribute or otherwise publish through the Web site any materials which (i) restrict or inhibit any other user from using the Web site, or contain a virus or other harmful component, (ii) violate any laws or violate or infringe any rights of third parties (including copyright, trade mark, rights of privacy or publicity or any other proprietary right), (iii) are not appropriate or pertinent to the purpose of the Web site or are libelous, defamatory or offensive, (iv) could otherwise damage the reputation of IAG or its service providers, or (v) promote or endorse any competitor of IAG or its brands. - You agree not to post any of the following: material that advocates illegal activity, advertising or any form of commercial solicitation, or copyright-protected files.
- You agree all information you supply to IAG is accurate and complete.
- You agree not to copy or download any material from the community.
- You warrant that you hold all intellectual property rights and proprietary rights to any information or materials submitted to the Web site.
- We have the right to use the ideas and information that you put forth in the community.
- You agree to receive emails from the Your Voice/Our Voice community regarding Your Voice/Our Voice community activities.

Your membership in and access to the Your Voice/Our Voice community is strictly at our discretion and may be revoked at any time without cause and without notice. You release us from any and all liability that may arise in connection with your use of the Your Voice/Our Voice community.

In the event that you do not qualify to become an Your Voice/Our Voice community member, personal information that you have provided to us during the registration process and in the introductory survey (such as your name, address and email address) will be deleted from the Your Voice/Our Voice database, but any aggregated information arising out of your participation in Your Voice/Our Voice surveys or discussions may still be kept, but you will not be identifiable.

IAG may use any personal information you have given to IAG in your capacity as an IAG customer and outside of Your Voice/Our Voice in accordance with the IAG Privacy Statement, including to send you communications from IAG (unless you have indicated otherwise).

### **Confidentiality**

The nature of the Your Voice/Our Voice community is interactive and public. By posting content, you understand and acknowledge that any materials, ideas or other communications you transmit in any manner and for any reason will not be treated as confidential or proprietary.

Information provided by you via the Your Voice/Our Voice community (including information you provide in the joining questionnaire) will be collected and stored by IAG in accordance with the provisions of this agreement and the Privacy Policy, and such information will be disclosed to Vision Critical Communications Pty Limited.

## **Assignment**

You irrevocably assign to us all rights in any ideas or expressions of ideas that you provide to the community. All comments, suggestions, graphics, ideas (including product and advertising ideas), and other information or materials you submit to us through this Web site will become and remain our exclusive property, including any future rights associated with such submissions, even if the terms and conditions of this Agreement are later modified or terminated. It also means that with the exception of your personal information, we have no obligation to keep your submissions confidential.

You further release and waive all claims against us with respect to any intellectual property or other proprietary rights, rights of privacy and publicity, rights of attribution, or any other liability under the applicable laws. You agree to indemnify and hold us harmless from all claims, actions, damages, costs, judgments, penalties or expenses of any kind whatsoever (including reasonable attorneys' fees except as provided herein), which may be obtained against, suffered by, or imposed upon us and/or our officers, directors, agents or affiliates as a result of any claim for its use of any information you provide through the community that was proprietary, confidential or protected by the laws of any jurisdiction.

## **Ending your Your Voice/Our Voice membership**

You may end your Your Voice/Our Voice membership at any time by clicking on the “Unsubscribe” link at the bottom of your survey or online discussion invitations or by emailing [support@iagyourvoice.co.nz](mailto:support@iagyourvoice.co.nz) with “Request Remove” in the subject line.

Once you have unsubscribed from Your Voice/Our Voice, any personal information (such as your name, address and email address) will be deleted from the Your Voice/Our Voice database and will not be used by IAG. Any aggregated information arising out of your participation in Your Voice/Our Voice surveys or discussions may still be kept but you will not be identifiable.
