

Terms of Use

Any use of palotteryinsiders.com and or any mobile sites, applications or platforms (collectively referred to as “the Website”) is subject to the following terms of use. Please review them carefully. Note that these Terms of Use differ substantially from those governing other websites, mobile sites, services, applications or platforms owned by the Commonwealth of Pennsylvania. If you are under the age of 18, please exit immediately and discontinue all use.

Introduction

Welcome to palotteryinsiders.com (“the Website”), an online community owned by the Pennsylvania Lottery and hosted by Vision Critical on behalf of the Pennsylvania Lottery. Individuals who want to participate in the online community created by the Website are invited to create an account which are subject to the following Terms of Use and the associated Privacy Policy.

Acceptance of Terms

By using this Website and/or its content, you hereby accept and agree to be legally bound by all of these terms. If you do not accept and agree to be bound by any of these terms, you should not register for an account and are not authorized to use this Website or its content.

Age Requirement

You must be at least 18 years of age to use this Website and content. If you are not at least 18 years of age, you are prohibited from using this Website and content.

Registration Requirements

In order to participate in the Website, you must first register as a member of palotteryinsiders.com by providing PAL with accurate, complete, and updated registration information as required by the profiling survey. The profiling survey will ask you questions

which may include, but are not limited to, your residence, age, your habits and attitudes, and gender.
