

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

The Saks OFF 5TH Advisors Sweepstakes (the "Sweepstakes") is sponsored by Saks Fifth Avenue OFF 5TH operated by Hudson's Bay Company ("Sponsor"). Sponsor is located at 225 Liberty St, 27th Floor, New York, NY 10281.

Eligibility: Sweepstakes is open to legal residents of the fifty (50) United States (including the District of Columbia) age eighteen (18) and older who have a valid email address at time of entry. Void where prohibited by law. Employees of the Sponsor, its parent company, subsidiaries, affiliates, retailers, distributors, advertising and promotion agencies and any other individual or company involved in the development or execution of the Sweepstakes, and members of their immediate families (parent, child, sibling and their respective spouses) of same households, whether or not related, are not eligible to enter.
