By entering this Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to extend or shorten this Sweepstakes or otherwise amend or cancel this Sweepstakes or amend these Official Rules. Two (2) verified winners will each receive one (1) \$250.00 Visa e-gift card.

**TO ENTER:** During the Sweepstakes Period, eligible individuals (see the ELIGIBILITY section of these Official Rules below) may enter the Sweepstakes by taking the short online survey or participating in the online discussion forum at the web site provided by the survey link in the email sent to you and following all applicable instructions. Upon completing the survey you will have the option to provide all required information to enter the Sweepstakes. **If you do not provide all**

**required information to enter the Sweepstakes, you will not earn an entry.** Surveys must be completed during the Sweepstakes Period for the associated entry to be eligible for the Sweepstakes.

All required information and actions must be received according to Sponsor's records during the Sweepstakes Period. Sponsor's clock will be the official timekeeper for this Sweepstakes. Those who do not provide the required information or abide by these Official Rules and other instructions of Sponsor or Administrator will be disqualified. The Administrator is an independent judging organization, whose decisions are final in all matters relating to winner selection in this Sweepstakes.
