

## The Box Seat Promotion Terms and Conditions

1. The promotion is open to residents of Australia aged 18 and over who receive an email from the Promoter or access the promotion through the Box Seat community. Employees and families of the Promoter and its affiliate companies, agencies and anyone professionally connected with the promotion are not eligible to enter.
2. No purchase necessary. Email recipients will be invited to participate in a survey via email or will access the survey via the Box Seat online community portal. The survey requires participants to answer one question. The entry question which participants must answer is “what was the best sporting moment you’ve seen live?” Competition entries open at 10/09/2019 9:00am and close at 10/10/2019 11:59pm. Only one entry per person allowed.
3. The Judging Period will take place between 11/10/2019 – 18/10/2019 at Level 7, George St, Sydney NSW 2000. The judges will select their favourite answer based on originality. Winners will be notified by e-mail on the day of judging and will also have their names published on the Box Seats member page.
4. There are 5 prizes in total (5 x \$50 Sportsbet Bonus Bet). Details on how to use the Bonus Bet will be available when sent to the winners. Bonus bet will expire a week after reception of the prize.
5. The prize is non-transferable and there is no cash alternative. If any prize (or part of any prize) is unavailable, the promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
