

VICE UK SURVEY AND PRIZE DRAW TERMS AND CONDITIONS

1. Please read these Terms and Conditions carefully before you participate in the VICE survey (the “**Survey**”) and subsequent prize draw (the “**Prize Draw**”) (together, the “**Survey and Prize Draw**”). Your participation in the Survey and Prize Draw is conditioned upon your agreement to these Terms and Conditions; if you do not agree with these Terms and Conditions, you must not participate in the Survey and Prize Draw. The organiser of the Survey and Prize Draw is Vice UK Limited, 110-122 New North Place, London, EC2A 4JA (“**VICE**”).
2. **Survey and Prize Draw Start Dates and End Dates:** The Survey and Prize Draw will run every three months from 1 July 2019 until 31 December in 2020 in accordance with the Survey and Prize Draw Dates Chart (the “**Chart**”) below. Each quarterly Survey and Prize Draw period will be referred to in these terms and conditions as (“**Survey Period**”). Each of the Survey Periods will begin at the times and on the respective starting dates indicated in the Chart. Each of the Survey Periods will end at the times and on the respective ending dates indicated in the Chart.
3. **Eligibility:** The Survey and Prize Draw is open to United Kingdom residents aged 18 and over. Entrants must (1) click on the link within the email containing the invite to the Survey or discussion, (2) answer all questions in the survey or a discussion with the Vice team and (3) successfully submit their answers each in respect of that survey or discussion with the Vice team in each month of the Survey Period in order to be entered into the Prize Draw. The Survey and Prize Draw excludes employees of VICE and their immediate families, and anyone professionally connected to the Survey and Prize Draw. The Winner may be asked to provide proof of ID. No purchase is necessary. Entries made from trade, consumer groups, third parties, agents, or entries automatically generated by computer will not be accepted. No bulk entries will be accepted.
4. **Prize Selection:** Ten [10] Winners will be selected in a random draw of the eligible participants during the Survey Period on or about the Random Drawing Date listed in the Chart below.

The decision of VICE is final and no correspondence or discussion will be entered into. If the Winner does not claim the prize in accordance with VICE’s instructions, their claim to the Prize will become invalid. VICE does not accept any responsibility if the Winner is not able to take up the Prize. VICE will make all reasonable efforts to contact the Winner. If the Winner cannot be contacted or is not available, or does not claim their prize within [5] business days of VICE sending notification via email, VICE reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the End Date of the Survey Period.
7. **Data Protection:** If you choose to participate in the Survey and Prize Draw, VICE will receive your email address and answers to the questions. If you are selected as the Winner VICE will ask you to submit your full name and email address with which to send your Prize. VICE must either publish or make available information that indicates that a valid award took place.
