



## **2020 PSEG Long Island Biz Panel Sweepstakes Official Rules**

OFFICIAL RULES 2020 PSEG LONG ISLAND BIZ PANEL SWEEPSTAKES. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

**TIMING:** The 2020 PSEG LONG ISLAND BIZ PANEL Sweepstakes (the “Sweepstakes”) is divided into twelve separate entry periods. Each Entry Period begins at 12:00 a.m. Eastern Time (“ET”) and ends at 11:59 p.m. ET. PSEG LONG ISLAND is the official timekeeper for the Sweepstakes.

**Entry Period 7:** July 1 – July 31

**Entry Period 8:** August 1 – August 31

**Entry Period 9:** September 1 – September 30

**Entry Period 10:** October 1 – October 31

**Entry Period 11:** November 1 – November 30

**Entry Period 12:** December 1 – December 31

**ELIGIBILITY:** Open only to legal residents of the State of New York, who are 21 years of age or older at the time of entry. The entrants must be PSEG Long Island customers in good standing during the entire Sweepstakes Period and at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from PSEG LONG ISLAND or their affiliates and the immediate family (spouse, civil union/domestic partners, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Void where prohibited.

Limit one (1) entry per PSEG Long Island account number regardless of method of entry. By participating, panelists acknowledge compliance with these Official Rules, including all eligibility requirements.

**WINNER SELECTION:** On or about February 3, 2020 for Entry Period 1, March 3, 2020 for Entry Period 2, April 3, 2020 for Entry Period 3, May 3, 2020 for Entry Period 4, June 3, 2020 for Entry Period 5, July 3, 2020 for Entry Period 6, August 3, 2020 for Entry Period 7, September 3, 2020 for Entry Period 8, October 3, 2020 for Entry Period 9, November 3, 2020 for Entry Period 10, December 3, 2020 for Entry Period 11, and January 3, 2021 for Entry Period 12 PSEG LONG ISLAND's designated third-party vendor will select one (1) entry for the prizes described below in a random drawing of all valid entries received. Each entrant selected will be contacted using the email address, telephone number and/or address provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). PSEG LONG ISLAND's decisions as to the administration and operation of the Sweepstakes and the selection 2020 PSEG LONG ISLAND BIZ PANEL Sweepstakes Official Rules are final.

**VERIFICATION OF POTENTIAL WINNER:** Potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be required to reply to and return to Sponsor, within five (5) days of the date email is sent, a winner notification survey in order to claim his/her prize.
