

## VICE VOICES PRIZE DRAW RULES

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** By entering the Vice Voices Prize Draw ("Drawing"), you agree to be bound by the terms of these Official Rules. If you do not agree to these Official Rules, please do not enter.
2. **HOW TO ENTER:** Beginning on [January 1, 2021] at 12:01 a.m. EST through [March 31, 2021] at 11:59 p.m. EST (the "Drawing Period"), you will be able to submit an entry via:
  - A. **Online Survey:** During the Drawing Period, you may log on to [https://voices.vice.com] and click on the icon for the **VICE VOICES SURVEY PRIZE DRAW** and (1) click on the link within the email containing the invite to the Survey or discussion, (2) answer all questions in the survey or a discussion with the Vice team, and (3) submit answers and receive confirmation of the submission, each in respect of that survey or discussion with the Vice team in order to be entered into the Drawing.
