# ACCEPTANCE OF PROGRAM TERMS AND CONDITIONS

These Twitch User Research Community Rewards Program Terms and Conditions (these "**Program Terms**") set forth the terms and conditions for the user research rewards program operated by or on behalf of Twitch Interactive, Inc. ("**Twitch**"). By participating in the Program, you agree to these Program Terms and the <u>Twitch Terms of Service</u> (these Program Terms and the Twitch Terms of Service are collectively referred to herein as the "**Terms**"), and you acknowledge the <u>Twitch Privacy Notice</u> ("**Privacy Notice**") applies. The Twitch Terms of Service and Privacy Notice are incorporated herein by reference.

Twitch reserves the right to periodically update and change these Program Terms and all documents incorporated by reference. You can find the most recent versions of these documents on the Twitch website or by clicking the links above. You should check these documents regularly for any updates. Your continued participation in the Program will constitute acceptance of any modified terms. In the event of any conflict or inconsistency between these Program Terms and the Twitch Terms of Service, these Program Terms will prevail, govern, and control with respect to any matters pertaining to the Program and the Twitch Terms of Service will prevail, govern, and control with respect to all other matters.

### 1. INTRODUCTION

1.1 The Program provides invited participants with the opportunity to earn "**Rewards**" by participating in certain research activities offered by Twitch and/or its third-party Program affiliates. If you participate in and complete designated research activities offered by Twitch and/or its third-party Program affiliates, you will be entitled to receive various Rewards as set forth below.

# 2. ELIGIBILITY AND ENROLLMENT

- 2.1 The Program is open only to individuals who (i) are of the age of majority in their state or country of residence; (ii) have a Twitch account in good standing; (iii) are not Twitch employees; and (iv) are not residents of countries currently subject to United States embargo or on the United States list of state sponsors of terrorism. Any person whose Twitch account has been terminated or suspended by Twitch is NOT eligible to participate.
- 2.2 The Program is provided to individuals only. Corporations, associations, or other groups may not participate in the Program. It will be considered fraudulent for any individual, company, club, association, or group to use or to direct, encourage, or allow other persons to use a single Program account for the purpose of accumulating or aggregating Rewards for combined use, unless such use is expressly permitted by Twitch.
- 2.3 Twitch will invite users to enroll in the Program at its TwitchCon conference, on its website, by email, and at other times, in Twitch's sole discretion. After you complete your registration, if Twitch decides, in its sole discretion, to accept you into the Program, you will be enrolled in the Program.
- 2.4 Limit one (1) Program account per person. You cannot have more than one Program account, even if you have multiple Twitch accounts. Twitch may, at any time, require you to verify your name and address by providing a copy of your driver's license or other form of identification approved by Twitch, in addition to providing Twitch with a signed statement of legitimacy; and Twitch may automatically require such verification in the case of multiple accounts from the same address, household, computer, or IP address. If you attempt to participate in the Program using more than one Program account, all unredeemed

Rewards in your Program account may be forfeited, and Twitch may, at its sole discretion, terminate your Program account and permanently ban you from participating in the Program.

The most current version of these Program Terms will be available on the Member Portal and will supersede all previous versions of these Program Terms.
- 5.2 The Program has no predetermined termination date and may continue until such time as Twitch decides to terminate the Program. Twitch may, in its sole discretion, modify or terminate the Program, in whole or in part, at any time and for any reason or no reason at all, with notice on the Member Portal or via email to your email address currently on file with Twitch for your Program account.
- 5.3 If Twitch decides in its sole discretion to discontinue the Program, for any Rewards that expire, you will have approximately thirty (30) days or an amount of time deemed reasonable by Twitch in its sole discretion from the date the Program termination is announced to redeem and use your remaining Rewards, if any. # 6. PROGRAM MALFUNCTIONS AND CONDUCT

6.1 Twitch is not responsible for lost, interrupted, inaccessible, or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or for any technical malfunctions, failures, or difficulties, or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information. Additionally, Twitch is not responsible or liable for any computer, programming, or printer errors, or for the unintended issuance or

redemption of any Reward or any particular type of Reward. In no event will Twitch be liable for, and you expressly release Twitch from, any claims as to the unintended issuance or redemption of any Reward or any particular type of Reward.
