

INSIDERS LOUNGE SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR SURVEY PARTICIPATION NECESSARY

- SWEEPSTAKES TIMING:** The Insiders Lounge Sweepstakes (the “**Sweepstakes**”) begins at 12:00 AM Eastern Time (“ET”) on 2/1/22 and continues through 11:59 PM ET on 1/31/23 (the “**Sweepstakes Period**”). Within the Sweepstakes Period, there will be twelve (12) monthly entry periods, starting on the first of each month from 2/1/22 through 1/1/23 and ending on the last day of each month (each, an “**Entry Period**”); for each Entry Period, the Sponsor will email invitations (each an “**Invitation**”) for select individuals to participate in one or more surveys. Each Invitation will include the entry deadline associated with that monthly Entry Period.
- ELIGIBILITY:** Open only to legal residents of the 50 United States and Washington, D.C., who are 16 years of age or older at time of entry and the original intended recipient of an Insiders Lounge Sweepstakes email invitation for the Entry Period associated with their entry. Void where prohibited by law. Only the original intended recipients of the Insiders Lounge Sweepstakes email Invitation will be eligible to enter the Sweepstakes associated with that Invitation. If you did not receive an Invitation to complete a survey within an Entry Period, you are not eligible for a chance to win in that Entry Period. A person may only use one email address to enter online. Completion of a survey is not required for Online Entry; see Rule #4 for details.

Box 7999, Melville, NY 11775-7999, to be postmarked within one (1) business day after the

close of the applicable Entry Period and received within five (5) business days after the close of that Entry Period to be eligible for that corresponding Entry Period only. **IMPORTANT:** You must hand-print the Entry Period deadline date, as indicated on your Invitation, on the bottom left corner of your outer mailing envelope. Limit one (1) Mailed Entry per mailing envelope. No mechanically reproduced or photocopied Mailed Entries permitted. Illegible/incomplete Mailed Entries are void. Not responsible for lost, late, mutilated, postage due, misdirected Mailed Entries or Mailed Entries not received in time for the corresponding random drawing.

All Online Entries and Mailed Entries will be collectively referred to as “**Entry**” or “**Entries**”.

5. **RANDOM DRAWINGS:** For each Entry Period, ten (10) winners will be randomly selected in a random drawing from among all eligible Entries received on or about 2 weeks after the close of that corresponding Entry Period. Drawings will be conducted by Sponsor’s designee, Don Jagoda Associates, Inc., an independent judging organization whose decisions are final and binding in all respects relating to the drawings. Odds of winning in an Entry Period will depend on the number of eligible Entries received for that Entry Period.
6. **VERIFICATION:** Potential winners will be notified by email using the email address to which their survey invitation was sent. If required, the response to such email must be received within three (3) business days after initial email was sent or potential winner will be disqualified and an alternate potential winner will be selected. Noncompliance within this time period may result in disqualification without further notice and an alternate will be selected. Sponsor assumes no responsibility for undeliverable email resulting from any form of active or passive filtering by email service providers or for insufficient space in user’s account to receive email. Return of any email or prize as undeliverable will result in disqualification and an alternate will be selected.
7. **PRIZES:** One Hundred and Twenty (**120**) Prizes [Ten (10) available to be won in each Monthly Entry Period] – A \$50 Visa e-gift code valid for online purchases. Winner must follow the instructions provided with their e-gift code to register their e-gift code online within 6-weeks of receipt.
