

OFFICIAL RULES AND REGULATIONS

1. **ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR TO WIN. "The CNN Community Sweepstakes" ("Sweepstakes") is open to all legal residents of the 50 United States and the District of Columbia, age 18 years or older who have Internet access as of **August 1, 2024** and who have been selected by Warner Bros. Discovery LLC ("WBD") to participate in the CNN Community, except employees, officers, and directors of WBD (the "Sponsor"), and its parents, subsidiaries, participating vendors, advertising and promotion agencies and affiliated entities (collectively, with the Sponsor and Administrator (as defined below), the "Sweepstakes Entities"). Sponsor has retained Alida Inc. ("**Administrator**") to administer the Sweepstakes. Void wherever prohibited by law. Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations. By entering the Sweepstakes, entrants agree to accept and be bound by all terms of these Official Rules and Regulations ("Official Rules"). Sponsor is not responsible for providing any Internet access or use.
2. **HOW TO ENTER:** Sweepstakes begins at 12:00 AM Eastern Time ("ET") on 8/1/24 and continues through 11:59 PM ET on 7/31/25 (the "**Sweepstakes Period**"). Within the Sweepstakes Period, there will be four (4) quarterly entry periods, starting on the first of each quarter from 8/1/24 through 7/31/25 and ending on the last day of each quarter (each, an "**Entry Period**"); for each Entry Period, the Sponsor will email invitations (each an "**Invitation**") for select individuals to participate in one or more surveys. These Official Terms shall apply to each Sweepstakes conducted throughout the year. To be eligible for a prize all entries must be received no later than 11:59:59 p.m. ET on the final night of a given Entry Period. All entries must be submitted in the name of an individual person and a prize can only be awarded to the person whose name is on a winning entry. Entries generated by script, macro or other automated means will be void. The Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware, or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect a person's ability to participate in the Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, errors that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond Sponsor's control, that corrupt the integrity, administration, security or proper operation of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to modify, cancel or suspend the Sweepstakes. In the event of cancellation, Sponsor reserves the right, in its sole discretion, to award prizes from among all eligible, non-suspect entries received prior to the event requiring such cancellation. False or deceptive entries or acts will render the entrant ineligible. All entries become the property of Sponsor and will not be acknowledged or returned. Limit one (1) entry per person or e-mail address per twenty-four (24) hour period. No entrant may win more than one (1) prize during a given Entry Period. Sponsor's computer shall be the official timekeeper for all matters related to this Sweepstakes.

3. **HOW TO WIN:** Five winners (collectively, the “Winners”) will be randomly selected within two weeks after the end of the Entry Period by a representative of Sponsor, from among all eligible entries received during a single Entry Period. For the sake of clarity, entries do not roll over into following Entry Periods. The decisions of Sponsor will be final and binding in all matters. The odds of winning will depend on the total number of eligible entries received during an Entry Period. Potential winners will be confirmed by email and must meet all eligibility requirements including the timely execution and return of all necessary releases and documents (if any) required by Sponsor. The Administrator will notify each selected entrant by email within 15 business days of the draw date.
4. **PRIZES:** Twenty **(20) Prizes** [Five (5) available to be won in each Quarterly Entry Period] – A \$200 Visa e-gift code valid for online purchases. Winner must follow the instructions provided with their e-gift code to register their e-gift code online within 6-weeks of receipt. Once registered, the e-gift code will expire 6-months from date of registration and unused funds will be forfeited. Additional terms and conditions may apply to e-gift code. Prize consists of only the item specifically listed as the prize. No substitution or transfer of prizes are permitted by the Winners. Prizes are subject to the any terms and conditions of the applicable Prize Provider. No substitution or transfer of prizes or cash redemptions permitted by the Winners. Sponsor reserves the right to substitute for any reason whatsoever a prize (or portion thereof) of comparable or greater value, at its sole discretion. Prizes are awarded “as is” with no warranty or guarantee, either express or implied by Sponsor. Prizes will be delivered by the Administrator’s third-party prize provider (“**Prize Provider**”), and the Prize Provider will contact the selected winner to fulfill the prize (as described below).
5. **GENERAL RULES AND REGULATIONS:** By entering this Sweepstakes, participants grant Sweepstakes Entities and their designees the right, unless prohibited by law, to use their names, cities and states of residences, voices, pictures and likenesses, without compensation, notification or approval, for the purpose of advertising and publicizing the goods and services of the Sweepstakes Entities and all matters related to the Sweepstakes, in any manner or medium, now or hereafter known, throughout the world in perpetuity. The winner will have five (5) calendar days from notification to accept the Prize by email. Potential Winners may each be required to execute an affidavit of eligibility, liability release, tax acknowledgment form and, except where prohibited by law, a publicity release and return within ten (10) business days of issuance of notification. Administrator and Sponsor are not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner. If a selected Entrant cannot be contacted within the allotted time, Administrator and Sponsor reserve the right to void that entry and select another eligible Entrant for that Prize. In order to be declared an official winner the selected Entrant will be required to complete and return to the Administrator a Survey Notification Form within five (5) days of receipt thereof from the Administrator. If a selected Entrant fails to complete and return the Survey Notification Form to the administrator within five (5) days, the Administrator reserves the right to void that entry and select another

eligible Entrant for that Prize. By completing and returning the Survey Notification Form, the Entrant is required to: (i) consent to Administrator providing the Entrant's name, email address and province/state details to Prize Provider for Prize Provider to contact the Entrant to fulfill the Prize; (ii) acknowledge that to fulfill the Prize, the Entrant may be required to set up a password protected account with Prize Provider and provide certain information, including: name, phone number, and mailing address. Sponsor and administrator are not responsible or liable for late, lost, or misdirected communications from the Prize Provider to the official winners email address.
