

Terms of Use

The following User Agreement ("Agreement") governs the use of the QB Solopreneurs community ("Community"), including without limitation participation in its bulletin boards, forums, chats, and all other areas (except to the extent stated otherwise on a specific page) as provided by Intuit Inc. ("Service Provider," "we," or "our") and/or its affiliate(s).

Please read the terms contained in this Agreement carefully. You can access this Agreement any time at www.qbsolopreneurs.com. **Your use of and/or registration on any aspect of the Community will constitute your agreement to comply with these terms.** If you do not agree with these terms, please do not use the Community.

In addition to reviewing this Agreement, please read our Global Privacy Statement (www.intuit.com/privacy/statement). Your use of the Community constitutes agreement to its terms and conditions as well.

The Agreement may be modified from time to time in our sole discretion. The date of the most recent revisions will appear on this page, so check back often. Continued access to the Community by you will constitute your acceptance of any changes or revisions to the Agreement.

Your failure to follow these terms, whether listed below or in bulletins posted at various points in the Community, may result in suspension or termination of your access to the Community, without notice, in addition to the Service Provider's other remedies.

I. Registration and Account Creation

1. REGISTRATION INFORMATION:

The Service Provider may at times require that you register and/or set up an account to use certain portions of the Community, or the Community as a whole. In order to do so, you may be provided, or required to choose, a password, User Id, and/or other registration information (collectively, "Registration Information"). You agree and represent that all Registration Information provided by you is accurate and current. If any of your Registration Information changes, you must update it by using the appropriate update mechanism on the Community, if available. Otherwise, contact us as described in our Global Privacy Statement.

2. USE OF USER ID/PASSWORD:

A. If you register and/or set up an account on the Community, you will be solely responsible for maintaining the confidentiality of your Registration Information. You may not authorize others to use your Registration Information. You may not sub-license, transfer, sell or assign your Registration Information and/or this Agreement to any third party without our written approval. Any attempt to do so will be null and void and shall be considered a material breach of this Agreement.

B. You are solely responsible for all usage or activity on your account including, but not limited to, use of the account by any person who uses your Registration Information, with or without authorization, or who has access to any computer on which your account resides or is accessible.

C. If you have reason to believe that your account is no longer secure (for example, in the event of a loss, theft or unauthorized disclosure or use of your Registration Information, you must promptly change the affected Registration Information by using the appropriate update

mechanism on the Community, if available, or notify us as described in our Global Privacy Statement.

II. Terms of Usage:

1. USE OF THE COMMUNITY BY YOU:

A. Unless otherwise specified, the Community is intended for your personal use only. You may not authorize others to use the Community, and you are responsible for all use of the Community by you and by those you allow to use, or provide access to, the Community.

B. The Community contains material that is protected by local, national and international copyright, trademark and other intellectual property laws. I. You hereby agree to keep confidential all Confidential Information you receive in connection with your participation in the Community. You acknowledge this is a legally binding obligation.
