# Terms of Use

The following User Agreement ("Agreement") governs the use of the The Insight Exchange ("Community"), including without limitation participation in its bulletin boards, forums, chats, and all other areas (except to the extent stated otherwise on a specific page) as provided by Intuit Inc. ("Service Provider," "we," or "our") and/or its affiliate(s).

Your use of and/or registration on any aspect of the Community will constitute your agreement to comply with these terms. If you do not agree with these terms, please do not use the Community.

The Agreement may be modified from time to time in our sole discretion. The date of the most recent revisions will appear on this page, so check back often. Continued access to the Community by you will constitute your acceptance of any changes or revisions to the Agreement.

### I. Registration and Account Creation

# **1. REGISTRATION INFORMATION:**

#### II. Terms of Usage:

#### 1. USE OF THE COMMUNITY BY YOU:
