

2026 PSE&G Power Talk Sweepstakes Official Rules

OFFICIAL RULES 2026 PSE&G POWER TALK SWEEPSTAKES. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

TIMING: The 2026 PSE&G Power Talk Sweepstakes (the “Sweepstakes”) is divided into four separate drawing periods. Each Drawing Period begins at 12:00 a.m. Eastern Time (“ET”), and ends at 11:59 p.m. ET. The period from the beginning of Drawing Period 1 to the end of Drawing Period 4 is referred to as the “Sweepstakes Period.” Public Service Electric & Gas Company (“PSE&G”) is the Sponsor of the Sweepstakes and is its official timekeeper.

Entry Period 1: January 1 – March 31, 2026

Entry Period 2: April 1 – June 30, 2026

Entry Period 3: July 1 – September 30, 2026

Entry Period 4: October 1 – December 31, 2026

ELIGIBILITY: Open only to legal residents of the State of New Jersey, who are 21 years of age or older at the time of entry. The entrant must be a PSE&G customer in good standing during the entire Sweepstakes Period and at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from PSE&G or their affiliates and the immediate family (spouse, civil union/domestic partners, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Void where prohibited.

HOW TO ENTER: During the Sweepstakes Period, you may enter the Sweepstakes in one of two ways: (i) join in the PSE&G Power Talk customer panel by filling out a demographic questionnaire; or (ii) complete a 3” x 5” postcard and mail it in a standard envelope with proper postage to: 2026 PSE&G Power Talk Sweepstakes, 505 Fifth Avenue 18th Floor, New York, NY 10017. The postcard must include your First Name, Last Name, Street Address, City, State, Zip, Phone Number, email address (if available) and Customer Account Number. Mail-in entries must be postmarked by March 31, 2026.

Limit one (1) entry per PSE&G account number regardless of method of entry. In the event that multiple entries are received for the same PSE&G account number, the authorized account owner at the time of entry will be considered the entrant. All entries become the property of PSE&G and will not be acknowledged or returned. By entering, entrants acknowledge compliance with these Official Rules, including all eligibility requirements.

WINNER SELECTION: On or about April 8, 2026 for Drawing Period 1, July 8, 2026 for Entry Period 2, October 8, 2026 for Drawing Period 3, and January 8, 2027 for Drawing Period 4, PSE&G’s designated third-party vendor will select six (6) entries for the prizes described below in a random drawing of

all valid entries received. Each entrant selected will be contacted using the email address, telephone number and/or address provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).

PSE&G's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Potential winners will be notified on or about April 8, 2026 for Drawing Period 1, July 8, 2026 for Drawing Period 2, October 8, 2026 for Drawing Period 3, and January 8, 2027 for Drawing Period 4. Failure to respond to the winner notification survey email within five (5) days of notification will result in disqualification and selection of an alternate potential winner in a random drawing of all remaining valid entries received. Odds of winning a prize depend on the number of eligible entries received during the Sweepstakes Period.

VERIFICATION OF POTENTIAL WINNER: Potential winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The potential winner will be required to reply to and return to Sponsor, within five (5) days of the date email is sent, a winner notification survey in order to claim his/her prize. If a potential winner of any prize cannot be contacted or fails to reply to the winner notification survey within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits the prize. In the event that a potential winner of a prize is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

PRIZE: one (1) \$150 Amazon Gift Card per eligible winner. Winners will be responsible for all taxes (including federal, state and local taxes) and any other costs and expenses associated with acceptance and use of the Prize not described herein as being awarded. All Prize details are at PSE&G's sole discretion.

PRIZE RESTRICTIONS: PSE&G reserves the right to substitute a prize of equal or greater value if the designated Prize is unavailable for any reason. Prize is non-transferable. Any depiction of the Prize in advertising is for illustrative purposes only. Value of the Prize will be reported to the IRS. All costs not specifically stated herein are the responsibility of the winner.

SWEEPSTAKES CONDITIONS: This Sweepstakes is subject to these Official Rules and all applicable federal, and New Jersey state laws and regulations. Any and all claims must be resolved in the courts located in Essex County, New Jersey. By participating, entrants agree as follows: a) to abide by these Official Rules, and to the decisions of PSE&G, which shall be final and binding in all respects; b) to the use of their names and/or likenesses and/or biographical data by PSE&G and its designees if selected as the winner for advertising, promotional and other purposes in any or all media now or hereafter known throughout the world in perpetuity without compensation, permission or notification (except where prohibited by law); and c) that PSE&G, its officers, directors, employees and agents and its third party vendor shall have no liability and shall be held harmless for any damage, loss, injury or death to an entrant or any third party in connection with participation in this Sweepstakes, or the use or misuse of the Prize.
